Civil Aviation Rules Part 91, Amendment 1

RULE OBJECTIVE, EXTENT OF CONSULTATION AND COMMENCEMENT

The objective of Part 91, Amendment 1 is to allocate an SSR code for civil helicopters operating within New Zealand that does not conflict with SSR codes allocated by ICAO to aircraft engaged in air transport operations when such aircraft are operating within New Zealand.

A draft of Part 91, Amendment 1 was developed by the Civil Aviation Authority, in consultation with the Airways Corporation of New Zealand. A Notice of Proposed Rule Making under Docket 1296 was published and distributed for comment on 18 September 1997.


The publication of this notice was advertised in the daily newspapers in the five main provincial centres on 18 September 1997. The notice was mailed to 102 members of the Regulatory Review Consultative Group who were considered likely to have an interest in the proposal.

A period of 14 days was allowed for comment on the proposed rule.

The submissions and verbal comments were considered and where appropriate the proposed rule amended to take account of the comments made.

Part 91, Amendment 1 was then referred to and signed by the Minister of Transport.

Part 91, Amendment 1 comes into force 28 days after notification in the Gazette.

Background to the Rules

Notice of Proposed Rule Making

To provide public notice of, and opportunity for comment on the proposed new rules, the Authority issued Notice of Proposed Rule Making under Docket Number 1296 on 18 September 1997. This Notice proposed the introduction of Civil Aviation Rules Part 91, Amendment No 1 to amend the SSR code allocation for VFR civil helicopters to avoid a conflict with codes used by international operations arriving into New Zealand.
